I, Atul Kumar Labh, Practising Company Secretary (FCS – 4848 / CP - 3238) and proprietor of M/s. A. K. Labh & Co., Company Secretaries, Kolkata was appointed as the scrutinizer in connection with the 31<sup>st</sup> Annual General Meeting (“AGM”) of the members of “*Simplex Projects Limited*” (“Company”) held on Wednesday, the 30<sup>th</sup> day of October, 2024 at 11:30 A.M. The management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013, MCA Circulars and the Rules relating to remote e-voting and e-voting at the AGM on the resolutions contained in the Notice of the AGM dated the 4<sup>th</sup> day of October, 2024. I submit my report as under:

1. The remote e-voting period remained open from 09:00 A.M. IST on Sunday, the 27<sup>th</sup> day of October, 2024 up to 5:00 P.M. IST on Tuesday, the 29<sup>th</sup> day of October, 2024.
2. The shareholders holding shares as on the “cut off” date, i.e. the 23<sup>rd</sup> day of October, 2024 were entitled to vote on the proposed 3 (Three) resolutions as mentioned in the Notice of the AGM dated the 4<sup>th</sup> day of October, 2024.
3. The Company had also provided e-voting facility at the AGM to enable the shareholders attending the AGM through VC / OAVM to cast the votes in case the same had not been cast by them through remote e-voting.
4. The votes were unblocked on Wednesday, the 30<sup>th</sup> day of October, 2024 around 12:50 P.M. IST after the completion of the AGM in the presence of two witnesses, namely, Mr. Rohit Kumar, residing at Basundhara Apartment, Flat No. 6, 3rd Floor, 1 No. Airport, North 24 Parganas, Kolkata - 700079 and Mrs. Anushree Dasgupta, residing at 28/N, Dwijen Mukherjee Road, Behala, Kolkata – 700060, who are not in employment of the Company.
